# **Privacy Policy**

Protecting your private information is our priority. This Statement of Privacy applies to www.rps365.com and Resolute Property Solutions LLC and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Resolute Property Solutions LLC include www.rps365.com and RPS. The RPS website is a Company News and Information site. By using the RPS website, you consent to the data practices described in this statement.

### **Collection of your Personal Information**

In order to better provide you with products and services offered on our Site, RPS may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number
- Employer
- Job Title
- Company and Company Principles and contacts information.

We do not collect any personal information about you unless you voluntarily provide it to us.
